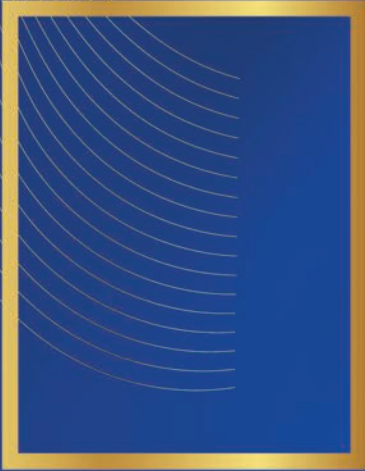

The Chris Connell Merit Awards honor the legacy of a leader who believed deeply in recognizing the dedication and bravery of public safety professionals at every level. Chris Connell served as Director of the Florida Capitol Police following a distinguished 28-year career with the Tallahassee Police Department. He was also a valued member of the Steering Committee for the Heroes in Public Safety Program until his passing in October 2019.

**Unsung Heroes:** Honoring individuals whose outstanding contributions over the past year may not always be seen, but whose impact is deeply felt.

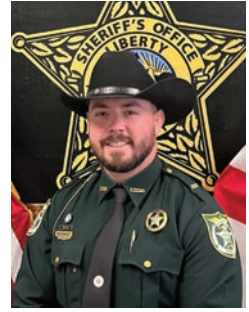
**Young Professionals:** Recognizing those early in their careers who demonstrate extraordinary commitment, professionalism, and service beyond what is typically expected of someone new to the field.

Liberty County Sheriff’s Office

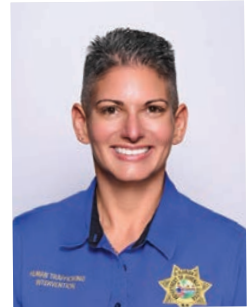

### Florida Fish and Wildlife Conservation Commission

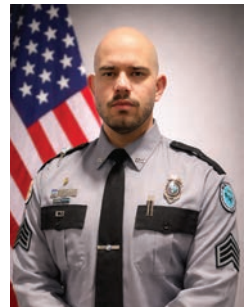

### **Florida State University Police Department**

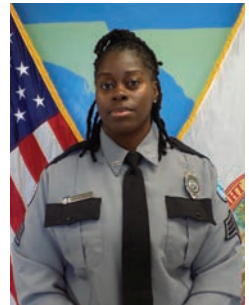

## **Safiya Richards,**

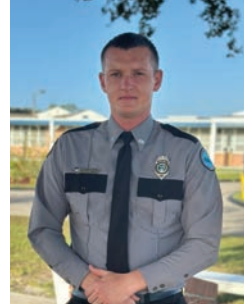
### **Florida Department of Corrections**

Florida Department of Corrections

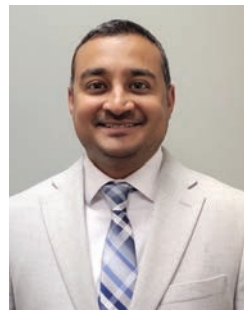

Florida Department of Corrections

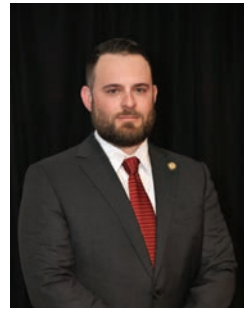

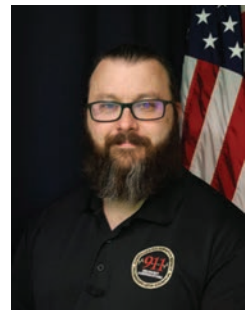
## **Tony Long,** Florida Department of Corrections

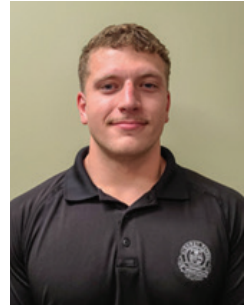
## **Tammy Pinkerton,** Tallahassee Police Department

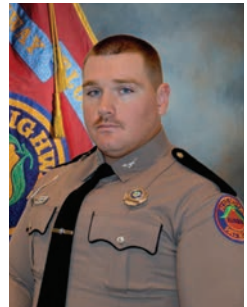
## Lee Kendall, Leon County EMS

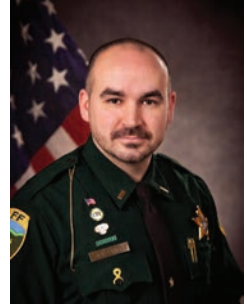
## Michael Kope, Florida Highway Patrol

### Gail Dunmyer,

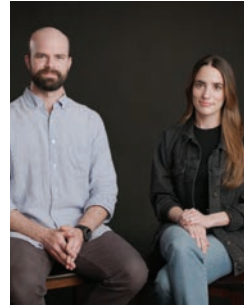
HCA Capital Hospital (RETIRED)

## PUBLIC SAFETY HALL OF FAME INDUCTEES CLASS OF 2026

### **Janet Hartman,**

**Tallahassee State College, Florida Public Safety Institute**

Janet Hartman has made a lasting impact on law enforcement and training across Florida. Rising to the rank of Chief with the Florida Division of Alcoholic Beverages and Tobacco, she led statewide enforcement operations and regulatory initiatives. In 2023, she was appointed Executive Director of the Florida Public Safety Institute, becoming the first woman to serve in the role. She now oversees critical training programs that serve thousands of public safety professionals, continuing to shape the future of law enforcement and criminal justice education statewide.



### **Mary Nicholson,**

**Tallahassee Leon County Dispatch Agency**

In her role with the Tallahassee–Leon County Consolidated Dispatch Agency, Mary Patricia Nicholson has provided steady leadership and operational expertise across public safety and higher education. As Employee Services Administrator, she oversees human resources and finance for mission-critical emergency communications. Her career spans senior administrative roles with the Leon County Sheriff's Office and multiple colleges, where she strengthened organizational systems, supported public safety operations, and advanced overall effectiveness through service-driven leadership.



## Marty West,

### U.S. Marshals Service

Marty West has served more than three decades with the U.S. Marshals Service, specializing in violent fugitive apprehension and multi agency operations. ## LIFETIME ACHIEVEMENT AWARD HONOREES

### **Robie “Janet” Carter,** Florida Department of Corrections

Few careers reflect the depth of commitment and service exemplified by Robie “Janet” Carter, who dedicated more than 60 years to the Florida Department of Corrections, all at Union Correctional Institution. Throughout her tenure, she held numerous clerical roles and served for decades as a clerical supervisor, earning widespread respect for her institutional knowledge, reliability, and professionalism. Her unwavering dedication across generations of change made her a trusted leader and a steady presence within the institution. Her legacy stands as a remarkable example of lifelong public service and enduring impact.



### **James Coker,** Florida Department of Corrections

A distinguished leader in corrections, James Coker has built a career spanning more than three decades with the Florida Department of Corrections. Rising through the ranks to serve as Warden and, most recently, Assistant Regional Director of Operations for Region I, he has overseen 19 state and privately operated institutions. Advancing aviation and special operations within the Leon County Sheriff's Office, Chief Joel "Lee" Majors has built a career defined by technical expertise and strategic leadership. Rising through the ranks, he commanded the Aviation Bureau and later led the Special Operations Division, overseeing highly specialized teams that support law enforcement across the region. 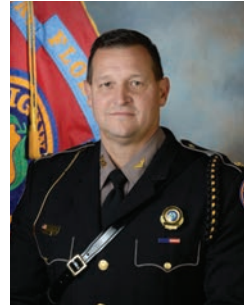
## **Robert Swearingen,** **Leon County Sheriff's Office (RETIRED)**

We honor the memory of the public safety professionals we have lost this past year, paying tribute to lives defined by service, dedication, and a steadfast commitment to protecting and serving our community.

## Deputy Sheriff Steven Bruner

Calhoun County Sheriff's Office

End of Watch: March 21, 2026

Deputy Bruner suffered a fatal medical emergency after assisting with the evacuation of residents during the Mossy Pond Fire. The fire covered more than 500 acres, forced widespread evacuations, and displaced dozens of residents. His service during this emergency reflects his dedication to protecting his community.



## Deputy Sheriff Jeremy H. Cassady

Escambia County Sheriff's Office

End of Watch: July 15, 2025

Deputy Cassady was seriously injured in 2010 when he was shot while responding to a domestic violence call, an incident that ultimately led to his medical retirement. Following the shooting, he underwent a kidney and pancreas transplant, and later developed cancer linked to the anti-rejection medications required for his treatment. Deputy Cassady served his community for six years with courage and dedication.



## Trooper Michael Diego

Florida Highway Patrol

End of Watch: February 18, 2026

Trooper Diego died in the line of duty after suffering a medical emergency while participating in a training exercise at the Florida Highway Patrol Training Academy. He served the Florida Highway Patrol and the citizens of Florida for more than four years, with assignments in Troop L and Troop F, and was a member of the 149th Recruit Class.



## Trooper Craig Gaines

Florida Highway Patrol

End of Watch: September 19, 2025

Trooper Craig Gaines passed due to medical complications from a duty-related injury. He served the citizens of Florida with the Florida Highway Patrol for more than 17 years and was a member of the 115th Recruit Class in Tallahassee. Trooper Gaines previously served with the Havana Police Department, the Gadsden County Sheriff's Office, and the U.S. Navy.



## Officer James Alexander Jackson

Florida Department of Corrections

End of Watch: August 15, 2025

Officer Jackson passed away at just 31 years old. A resident of Winter Haven, he dedicated his career to serving at Hardee Correctional Institution, where his professionalism, strength, and good nature left a lasting impact on those around him.



## Deputy Sheriff Devin Jaramillo

Miami-Dade Sheriff's Office

End of Watch: November 7, 2025

Deputy Jaramillo was fatally shot while responding to a traffic crash, where he was attacked upon arrival. He served his community with the Miami-Dade Sheriff's Office for five years and seven months.



## Deputy Sheriff Andres Julian "Andy" Lahera

Citrus County Sheriff's Office

End of Watch: September 11, 2025

Deputy Lahera succumbed to injuries sustained on May 23, 2023, when he was struck by a vehicle while directing traffic. He served his community with the Citrus County Sheriff's Office for 14 years.



## Sergeant Terri Jean Sweeting-Mashkow

Indian River County Sheriff's Office

End of Watch: November 21, 2025

Sergeant Sweeting-Mashkow was fatally shot while serving an eviction notice when a subject approached and opened fire. She served her community with the Indian River County Sheriff's Office for 25 years.
