NEW BUSINESS

Budget Update

- Mike Fraser updated the council members on the current budget position.
- Members were provided with a copy of the FY 23-24 audit findings. Region III received a perfect audit and was recognized before the Commission. A letter accepting the audit findings will be sent to FDLE.
- Members were presented with the amended FY25-26 budget forms. Due to the outcome of the legislative sessions, funding for Region III was reduced by approximately \$ 3,200. The newly approved budget will be sent to FDLE by September 15.
- Members were provided with the second semi-annual report for FY 24-25. As planned, the funds were overspent by approximately \$600. FPSI will pay the overage, and the region will not send back any money.
- Members were provided with the status of the current FY budget. The budget has approximately \$6,000 to be spent on training.

Commission Updates

Director Lane presented the updates from the CJSTC Commission meeting held on August 11-15, 2025.

- Members were reminded that officers must complete the new Lethality Assessment training and then provide a letter to FDLE by June 2026, stating all officers have completed the training.

- Survival Flight has been approved and plans on building a new hangar and housing complex at FPSI.
